

1. The Principal will relevantly strive to arise bars of quality towards the fulfillment of purpose for which the is Established.
2. To participate in the college activities like teaching, research and training.
3. To do planning of academic activities and implement them
4. To give admission to student and observe discipline
5. To look after the management of library, laboratories, gymkhana, hostel etc.
6. To keep accounts and submit account statement to the institution and LMC
7. To follow rules of accounts
8. To do administrative correspondence
9. To do administration, supervision and keep record of curriculum, activities supplementary to curriculum, student development activities and students' welfare


1. Name of the Society : SHRI VIKASHBHANDRA EDUCATION SOCIETY HARUGERI

3. The aims and objects of the Society:

- a) The main objects of the Society shall be to impart Primary, Pre-Primary, Secondary and all kinds of Higher Education and to start free Boardings and Hostels for the poor students and to run Libraries for the Public.
- b) In pursuance of the main objects of the Society, the Society may manage or take over any educational institutions and Libraries already running by the other managements.
- c) The society may acquire, purchase or hold any building or open site including grounds, or any other property immovable including lands & buildings. It may construct alter, extend or otherwise maintain as per its needs, any building or other property on behalf of the society for its benefits.
- d) The society may collect donations, funds including property both movable and immovable, subscriptions etc., from the public for the benefit of the society in pursuance of its objects. Such collections shall be treated as gift and is not refundable.
- e) The society may spend, invest, dispose or otherwise deal with the funds and the property of the society for the benefit of the society.
- f) The society may invest or start any honourable business such as printing presses, Book stalls etc., for the benefit of the society, subject to the approval of the governing body.
- g) The society shall be a purely Educational body and Non-Political character.

The Secretary of the above association is authorised to carry on the correspondence between the association and the Registrar Societies for Registration and other matters.



i) A Grand Patron: is one who has donated to the society in a lump sum or in instalments agreed to by the managing committee but within a year, a subscription of Rs.5,000/- or more.

c) A Patron: is one who has donated to the society in a lump sum or in instalments agreed to by the Managing committee, but within a year subscription of Rs.2,000/- or more.

d) An Ordinary Member: is one who have donated to the society a sum of Rs.500/- or more in a lump sum and has been accepted as such by the Board of Management.

e) An Honorary Member: is an eminent educationalist sympathising with the work of the society and elected as such by the Board of Management.

N.B. A person is eligible to be a member of the Society on his attaining the age of 21 years, provided he is not a student and provide also he is not an employee of the society, other than the Head of the Institution.

A person convicted in a Court of law for any offence involving moral turpitude or who is insahme, cannot become or continue as a member of the society through previously accepted as a member. Provided also that no members of any of the classes above referred to, shall be entitled to exercise his rights as a member until he has paid up the full amount as prescribed above.



iii) The term of the Committee shall be four years. A casual vacancy or vacancies caused by resignation, absence, death or removal by the Committee as per General rules and approved by the occurred. The term of the such nominated members shall be with that of the sub committee.

iv) The Committee shall be responsible for the general welfare of the society and for this and it has power maintain discipline, to supervise and control the administration of the society. It has also responsible for the implementation of the resolutions

v) It has power of appointment, punishment, removal or otherwise of the servants as the Society and of its institutions. It has power to frame service rules and regulations in accordance the directions of the General body and it may promote or remove any servant of the society or and institutions in the interest of the society.

vi) It may remove any of its members by 2/3rd majority and recommend to the general body to remove any member of the Committee.

vii) It may frame general rules or sub-rules for its own welfare and the working of the society and of the institutions of the society and get sanctioned by the general body of the society.

viii) It may appoint a sub-committee for specified purpose and delegate any of its powers to sub-committee such committee shall cease to exist when the purpose is completed.

ix) It may admit provisionally new members to the society as per the rules and get sanctioned by the general body.

x) It may do any other thing in accordance with the spirit and purpose of the

- xii) The committee shall be meet atleast once in a month. The meeting shall be called by the Chairman or the general Secretary by 7 clear days notice along with the agenda for special meeting by 3 clear days notice. The adjourned meeting shall take the same work. The minutes shall be kept the Secretary and signed by the presiding authority.
- xiii) No resolution once passed can be deleted or cancelled within three months of the passing.
- xiv) The committee is responsible for the maintenance of proper accounts of the society. It has power to appoint auditors of the society.
- xv) All the expenditure of the society or of its institutions shall have the prior sanction of the managing committee.
- xvi) There shall be no personal responsibility of any member of the committee for any act done in good faith and in the interest of the society.
- xvii) Whenever the work of any institutions of the society is on the agenda, the head of such institute shall be given notice as through he is a member of the committee. For this purpose he shall be an ex-office member of the committee. He can take part in the discussions concerned to this institute, but has no voting power.
- xviii) The committee may raise loans upto Rs.10,000/- (by pledge or otherwise with the consent of the trust committee) and if more than Rs.10,000/- by the consent of the trust committee and the approval of the general body.

#### 10. The General Body:

- i) The General Body shall meet at least once in a year in the month of May. The meetings of the General Body shall be called by its president or the chairman of the Managing Committee or the General Secretary of the society.
- ii) A meeting of the General Body may also be called by 21 days requisition notice signed by atleast 1/5th of the total members of the society for a specific purpose. As per section 11 & 13 of the K.S.R. Act 1960.
- iii) Every ordinary meeting shall be convened by atleast 15 days clear notice and every special General Meeting by 21 days clear notice.
- iv) Atleast 25 members or 1/5th of the total member whichever is less shall form a quorum, a meeting shall be adjourned if there is no quorum. Such adjourned meetings shall conduct business with quorum and shall conduct the affairs which were kept before the original adjourned meeting.

- 1) Any resolutions passed may be altered or deleted by 2/3rd majority at a special meeting called for said purpose but not within six months from the date of passing.
- 2) Proceedings and minutes of the meeting of the society shall be kept and shall be signed by the president in authority.
- 3) The society may appoint a General Secretary of the society who shall be deemed to be the servant of the society, and the society may direct the Managing Committee to fix the scale of pay, services rules etc., of the servants of the society.
- 4) Every member present shall have one vote and the voting shall be by raising of hands. The Presiding authority may take into consideration the seriousness of the situation order the voting ballot and he shall declare the result. Ordinary member has no voting power. Special general body shall be made as per section 11/13 of the K.S.R. Act 1960.

✓ 11) Trust Committee:

- 1) The Committee shall have minimum five and maximum eleven members, the terms of the committee shall be for four years.
- 2) All permanent property, building, grounds, furniture, books, permanent funds, special donations and other permitted by the society and its Institutions shall vest in the trust committee.
- 3) It shall elect its first meeting after its constitution the chairman etc.,
- 4) The procedure to call the meeting etc., of the committee shall be as those of the managing committees.
- 5) Any loan to be raised by way of pledge of any trust property shall not take place without recommendation of this committee.
- 6) The committee has power to do any investment in a sound business of profit with the approval of the Managing Committee.
- 7) The Committee has power to do all other acts permitted by the rules of the society and rules there under if any.
- 8) No individual responsibility is cast upon any member of the Committee for the act done in good faith and in the interest of the society.

General Secretary:

The General Secretary is authorised to correspond and to maintain accounts and documents of the society. He shall attend meetings of the society and its committees. He is responsible for the maintenance of the minutes of the same. He shall have general control over the servants of the society.

Organiser:

or sent by post to every member of the society twenty one days previous to the date of the special general meeting

convened by the managing body for the consideration therefore, and unless such proposition shall have been agreed
